Purpose:

The seat backs on the forward facing seats have been reported to be coming loose after time in service. This Service Release announces the availability of a modification kit that will provide positive securing of the seat back cover and install a seat back plate for additional support. These refinements are accomplished by adding clip nuts to the two (2) top screws and providing the seat back plate with the necessary hardware.
